The Labadie Collection is a special collection mostly dealing with American anarchism. However, there is a significant portion of the collection devoted to Spanish anarchism 1931-1939.

There are 135 scarce pamphlets in this collection on Spain, of which 71 deal with the Anarchists and 11 with the POUM (Partido Obrero Unificación Marxista).

There is also some unpublished private correspondence concerning the POUM and the Anarchists including that of Emma Goldman (American); Helmut Rüdiger (German); A. Jensen (Swedish); the AIT, Association Internationale des Travailleurs (Paris); CNT, Confederación Nacional del Trabajo (Barcelona); and the Freie Arbeiter Stimme, a Yiddish paper in New York which had ties to the POUM and CNT.

At the University of Michigan Library there is a 39-page guide to the Spanish portion of the Labadie collection, written in 1958 by this author. The guide is also cited in Juan Garcia Duran, Bibliography of the Spanish Civil War 1936-1936 (Montevideo, Editorial El Siglo Ilustrado, 1964.)

#### CONFERENCE GROUP ON MODERN PORTUGAL

In the February 1974 issue of the European Studies Newsletter, published by the Council for European Studies, there will be a summary report of the proceedings of the Workshop on Modern Portugal held at the University of New Hampshire from 10-14 October last year. There were present at this Workshop 59 conferees, including three professors from Portugal, three from England, and several others from Europe and Brazil. The Conference Group on Modern Portugal, formed at Madison, Wisconsin, in June 1972, plans to publish an edited set of the Workshop papers in a special issue of the Luso-Brazilian Review in December 1974, under the editorship of Douglas L. WHEELER (History, University of New Hampshire) and Joyce RIEGELHAUPT (Anthropology, Sarah Lawrence). The Conference Group on Modern Portugal has also expressed a desire to affiliate with the SSPHS, and, through organizing sessions at SSPHS annual meetings, to continue to advance modern Portuguese studies.

#### ESPANA IBERO-AMERICA Y EL MUNDO ANGLOSAJON

Martin C. NEEDLER (Director, Division of Inter-American Affairs, University of New Mexico) announces that he is organizing a small conference, "España Ibero-américa y el mundo anglosajón," to take place in Madrid, April 4-7, 1974, under the sponsorship of the Instituto de Cultura Hispánica. The conference flows out of a panel at the Fourth National Meeting of the Latin American Studies Association in May 1973, and is designed to explore the ways in which study of Latin America and study of Spain can reciprocally reinforce each other. A report of the conference is planned for publication. There will be participants from Spain and other Western European countries. Those from the United States planning to attend include Charles ANDERSON, Murdo MACLEOD, Martin NEEDLER, Stanley PAYNE, Ann PESCATELLO, and Howard WIARDA.

#### MODERN GREEK SOCIETY

Modern Greek Society is a newsletter published by and for social scientists with a special interest in Greece. Its purpose is to provide a regular channel of communication among scholars studying modern Greek society in the fields of anthropology, economics, history, political science, sociology and related disciplines. It also aims at promoting contacts and exchanges between scholars studying Greece, and those studying other societies of Mediterranean Europe, and hopes to contribute to the growing interest in comparative analysis of the area.

LIDA (History, Wesleyan University) has been awarded a renewal of her 1972-1973 research grant from the Joint Committee on Latin American Studies of the Social Science Research Council and the American Council of Learned Societies to study, during 1973-1974, the impact of 19th-century Spanish immigration on the labor movement in Argentina.

J. D. VINCENT-SMITH (Modern Portugal) reports that he completed a dissertation, Britain and Portugal, 1910-1916, for London University in 1971.



CURRENT RESEARCH INVENTORY

G. B. BLEDSOE (Modern European History, Randolph-Macon College) was in Madrid during January 1973, finishing research for a short work on the organization and philosophy of the Unión Patriótica under Primo de Rivera. He has finished two articles, both currently in the hands of editors, one on Spanish attitudes towards disarmament prior to 1936, and the other on the League "crisis" of 1926. He would like to hear from others working on the Primo de Rivera period.

Earl R. BECK (History, Florida State University): "Cánovas del Castillo: the Dictatorship." Research in Madrid, December 1972 - June 1973. Estimated completion, 1975.

Charles JAGO (Early Modern European History, McMaster University): Fiscal reform during the reign of Philip IV with particular emphasis on the fiscal theories then current and on the role played by the Castilian Cortes in the adoption and implementation of tax reforms.

Helen NADER (Early Modern Spain, University of Hawaii): The Renaissance in Spain, 1350-1550. A study of Renaissance humanism within the Castilian aristocracy, from Pedro Lopez de Ayala to Diego Hurtado de Mendoza. The study analyzes the rhetoric and attitudes of the principal historical writers of the period and the social and political circumstances in which they wrote. I have received a fellowship from the ACLS and will spend the period September 1974 through May 1975 in Spain.

S. J. MILLER (17th and 18th Century Europe, Boston College): "Portugal and the Holy See: an Aspect of the Catholic Enlightenment, 1730-1830." An attempt to see Sebastião José de Carvalho e Melo and his circle (António Pereira, Manuel do Cenáculo, Francisco de Lemos, João Baptista de S. Caetano, Francisco de Almada, et al.) in a somewhat different light from Fortunato de Almeida, that is, as a companion piece to Bernardo Tanucci, Gerard van Swieten in Reform Catholicism (Enlightened Catholicism) in the 18th century. Based on research in Oesterreichs Staatsarchiv, Archivio Segreto Vaticano, Torre do Tombo, Arquivo Distrital de Evora, University Library (Coimbra), Biblioteca da Ajuda, Biblioteca Nacional de Lisboa, and Rijksarchief in die Provincie Utrecht, and others.

Ann M. PESCATELLO (History, Florida International University): Research and revision of my doctoral dissertation for publication: Both Ends of the Journey: An Historical Study of Migration and Change in Brazil and Portugal, 1889-1914 (UCLA: University Microfilms, 1970). The thesis dealt with the cause and effect of emigration from and on Portugal, and immigration to and on Brazil. Estimated date of completion: 1974-1975

Mario RODRIGUEZ (Latin American History, University of Southern California): I am presently tightening and polishing the style of a

nine-chapter study that will bear the title, The Cádiz Experiment in Central America, 1808 to 1826. It attempts to analyze the liberal program that developed in Spain and overseas during the Cádiz constitutional period; how Americans, and especially the Central American delegates, contributed to that program; how the experiment fared in Central America before and after Independence; and how Spaniards managed to alienate Americans, thus contributing to the psychology of Independence. The study is based on documentation from archives in Central America (Archivo General de Centroamérica, Guatemala City; Archivo Nacional, Tegucigalpa; Archivos Nacionales de Costa Rica) and in Spain (Archivo Histórico Nacional; Archivo General de Indias); and other repositories in both areas for collections of newspapers, broadsides, etc.

Barbara Hadley STEIN and Stanley J. STEIN (Spain and Mexico, Princeton University): Research and writing continued on Merchant and Monarch in Spain and New Spain, 1759-1829. Estimated date of completion: Summer, 1976.

Gabriel TORTELLA-CASARES (Economic History, University of Pittsburgh): Money and Banking under the Restoration, 1874-1914, planned for completion in 1974. The Beginnings of the Spanish Chemical Industry: La Sociedad Española de la Dinamita (Patente A. Nobel), also planned for completion in 1974.

Robert H. WHEALEY (History, Ohio University): As a result of work in the Archivo Histórico Nacional, Madrid, I am writing an article which, with the use of 9 tables, will show how the Nationalists paid for the Spanish Civil War. Since John R. Hubbard wrote an article in 1953, "How Franco Financed His War," I plan tentatively to call my article, "How Franco Financed His War, Part II." It will be completed in February or March 1974. An abstract of the article will be presented as a paper at the March 1974 meeting of the SSPHS at the University of California, San Diego.

Iris M. ZAVALA (18th and 19th Centuries, SUNY at Stony Brook): I am finishing a book, Clandestinidad y libertinaje erudito en los albores del XVIII, for Ariel. I have been working on this project for the past ten years. I aim to show that the "luces" are a prolongation of the humanist and "arbitrista" thought, as much as the temper and tempo of a deep social transformation. Spanish liberal and progressive thought kept in clandestinity; far from being a copy of France or a totally new trend of thought, it is the reorientation of already actively productive forces from the previous century. I will stress the role of clandestine thought, of popular literature and the effect all these had in creating a new perception of the world. My main effort will be to relate culture and society, trying to profit from economic and social historians.
