MINUTES OF THE 1973 MEETING

The Annual Business Meeting of the Society for Spanish and Portuguese Historical Studies was called to order on Sunday, April 8, 1973, at 3:00 p.m. in the Whithall Pavilion of the Library of Congress by the Acting General Secretary of the Society, Michael Weisser.

- I. The Acting General Secretary reported assets of approximately \$2,300, and announced that an official auditor's statement was being prepared.

The Society's claim of tax exempt status was reported to be in the final stages of IRS deliberation, but it was noted that a change in the Society's by-laws was necessary regarding disposal of funds in the event of the dissolution of the organization. (See enclosed ballot).

On behalf of the Society the Acting General Secretary formally thanked Mr. Earl J. Pariseau, Acting Chief, Latin American, Portuguese, and Spanish Division, Library of Congress, and his staff for their support and attentions rendered in the cause of the Conference.

On behalf of the Society the Acting General Secretary formally thanked guest speaker Professor Jorge Nadal (Universidad Autónoma de Barcelona) for his contribution to our proceedings. By general acclamation he was voted an honorary membership in the SSPHS.

- II. Executive Committee member Stanley Payne reported on the Society's discussions with ISSA concerning the possibilities of forming a closer working relationship. The question of editorial participation was raised, and it was decided over that matter to allow the discussion to lapse.
- III. Annual Meeting: By a near unanimous vote it was decided to hold the Fifth Annual Meeting at San Diego. Gabriel Jackson, Department of History, University of California, San Diego, assumed interim responsibility for arrangements. (See notice of 1974 Annual Meeting).
- IV. Program Committee: It was proposed that the Executive Committee select one member to serve as chairperson of the Program Committee, and that he/she select two other persons, at least one of whom would be drawn from outside the Executive Committee. This Program Committee would assume responsibility

for planning the program of the Fifth Annual Meeting, along with selection of an AHA panel for that organization's 1974 meeting in Chicago. That Program Committee would also be charged with exploring the possibility of a joint session with CLAH or the Italian Historical Association at the AHA meeting. The proposal was accepted by the membership.

- V. Elections: The following received more than one nomination for the Executive Committee: G. Jackson, R. Kagan, T. Kaplan, J. Linz, N. Sánchez-Albornoz, B. Stein, J. Ullman, M. Weisser, and I. Zavala. The following asked to have their names withdrawn: R. Kagan, J. Linz, and B. Stein. It was suggested that N. Sánchez-Albornoz and I. Zavala run for the vacancy on the Nominating Committee, as they have both served consecutive terms on the Executive Committee. This was agreed to, and the slate was accepted by the membership.
- VI. Prizes: The Executive Committee reported that they had received one entry for the prize for a published essay within five years after the Ph.D., and no entries in the category of graduate student essays. It was decided to extend the consideration of entries to December 31, 1973, and to hold the possibility of awards over until the 1974 meeting. (See notice of prizes within).

Portuguese literature published before 1850 on economics is not well covered bibliographically. There is a good bibliography of the works of the major economists--Moses Bensabat Amzalak, Do estudo e da evolução das doutrinas económicas em Portugal (Lisboa, 1928)--which also contains critical comments and notes on the secondary literature. Nevertheless, it is not exhaustive. For instance, José Luiz Mouta de Gouvea e Vasconcellos, listed below under the year 1780, is not included. Nor is Amzalak interested in descriptive works, as opposed to theoretical treatises.

Another useful bibliography is Catálogo da exposição de historia do Brazil realizada pela Bibliotheca Nacional do Rio de Janeiro a 2 de dezembro de 1881 (Rio de Janeiro, 1881; 2 vols.). It is a classified catalogue, so that the economic literature is readily accessible.

Except for the above-mentioned bibliographies, to our knowledge no other work produces more than just a few titles for the historian concerned with economic questions. As great a bibliography as Innocencio Francisco da Silva's Diccionario bibliographico portuguesa (1858-1923; 22 vols.) is, it does not serve the historian's purpose because it lacks a subject index. Neither do the catalogues of the major Luso-Brazilian collections in the United States lead the historian to the economic literature. Such material tends to be a neglected area in the collecting of private individuals and libraries. Hence, this list of the Kress Library's holdings is a modest contribution to the bibliography of the field, with the advantage to the scholar of providing a location for all the works listed.

The material published before 1800, along with the pre-1800 titles in the Goldsmiths' Library at the University of London, is being published in roll microfilm and microfiche by Research Publications, Inc., New Haven, Connecticut. Although scholars will shortly be able to acquire microfilm copies, we always welcome use of the material in person. The Kress Library can particularly help the historian working on a cross-cultural topic, since we collect pre-1850 literature

published in Danish, Dutch, English, French, German, Italian, Latin, Portuguese, Spanish, and Swedish. Although we believe our Portuguese holdings constitute a notable portion of the total Portuguese output, they make up only a small portion of the Kress Library's 25,000 titles.

SPAIN IN THE SEVENTIES: PROBLEMS OF CHANGE AND TRANSITION

SOCIETY FOR SPANISH AND PORTUGUESE HISTORICAL STUDIES: PRIZES

David Wingate PIKE (American College in Paris, 31 Avenue Bosquet, Paris 7, France) writes: "I recently found some documents in the archives of the Département de l'Aude, which I have photostated. They are apparently an official French transcript (or possibly a translation into French) of a series of communications from Vienna, Steyr, Zurich, and Berlin dated August and September 1937, concerning gun-running to Spain across the French border. The difficulty lies in identifying the organization, or at least its political ideology, as no theory quite fits. The key characters are BALATCHOVSKY, Wilhelm FUCHS, Rupert SAUDERMAN, and especially Stefan ORTWEG. If anyone in the Society might be interested in this problem, I would be happy to send a photostat copy."
